**Localism Act 2011, Sections 28 & 29
The Relevant Authorities (Disclosable Pecuniary Interests) Regulations
2012**

In order to comply with the Parish/Town Council's Code of Conduct, a Member or Co-opted Member (M) must register their pecuniary and interests other than pecuniary interests with the District Council's Monitoring Officer within 28 days of the date of their election or co-option. *(Failure to declare a disclosable pecuniary interest is a criminal offence).*

Note – A Member must, within 28 days of becoming aware of any new interest or change to any interest specified above, register details of that new interest or change by completing a new Register of Interest Form and submitting it to the Council's Monitoring Officer.

Important Notes – You may complete this form electronically but you must print it out and personally sign the completed form.

If in doubt about whether or not something should be declared, you are urged to err on the side of openness and avoid the risk of not registering something in error.

DISCLOSABLE PECUNIARY INTERESTS

3. Details of any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority –


(a) under which goods or services are to be provided or works are to be executed; and

(b) which has not been fully discharged.


4. Details of any beneficial interest in land which is within the area of the relevant authority.


5. Details of any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.



6. Details of any tenancy where (to *M's* knowledge) –
- (a) The landlord is the relevant authority; and
 - (b) The tenant is a body in which the relevant person has a beneficial interest.



7. Details of any beneficial interest in securities of a body where
- (a) That body (to *M's* knowledge) has a place of business or land in the area of the relevant authority; and
 - (b) Either –
 - (i) The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - (ii) If that share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.


