In preparing a presentation for the meeting please bear in mind that, in assessing the application, the Development Panel must consider the following things:

- The Allerdale Local Plan
- Other material planning considerations e.g. national planning policy

As a general principle, the planning system works in the public interest and matters that affect solely private interests are not usually material considerations in planning decisions. Examples of things that can't be taken into account include: loss of a view; reduction in property value, land ownership or restrictive covenants; business competition, the levels of profit to the developer, disturbance during building works or other matters controlled under building regulations or other non-planning legislation such as that relating to licensing or health and safety.

It is important that the presentation focuses on the planning reasons for any objection and please bear in mind that planning decisions have to be made on the strength of the planning arguments and not by weighing up the number of objectors or supporters.
