10.3.22 Parish Maintenance -

- **Grass Cutting** a number of complaints have been received and Mr Armstrong has ben asked to make contact with previous contractor for a price to take over the service. To be discussed at the next meeting.
- Dovenby Footbridge A number of concerns were raised about the siting of the bridge and how this might impact on road safety, particularly with young people who may be at greater risk of running out into the road. Mr Hodgson had discussed this with Mr Denton, who has quoted Highway Regulations and does not see the need for further intervention. Mr Armstrong is proposing that there should be further safety measures put in place. Lengthy discussion took place and it was resolved that the Clerk is to make contact with Mr Denton, the Countryside Officer to ask him to attend the next meeting to discuss the options as the Parish Council do not wish to be held responsible for the decisions taken by an outside body that may impact on parishioner safety.
- **Speed Limit in Dovenby** This is due to be reduced to 40mph in June 2022, this is a delay on the original proposed timetable.
- **Potholes in Bridekirk** These have been repaired, but already breaking up as the work had been of a temporary nature, not dug out properly.

11.3.22 M Sport -

Planning application received in relation to M Sport, but this could not be properly considered as there were numerous errors in the information provided. Clerk to speak to Allerdale Planning Department to challenge this.
