People should have a look to see what is being proposed in it. • Flooding – Rivers Trust have been out and looked at site in Dovenby. Because sediment is toxic to fish they are happy to have the silt removed. • Derwent Catchment – Draft plan is out on 13.5.16. Flood related content. • Cockermouth, Keswick & Workington had been left of the list of beneficiaries for money to repair flood issues, this is because they will be dealt with through a separate fund to this £50m 	
10.5.16	<p>Planning applications</p> <ul style="list-style-type: none"> • 18/04/2016 Proposed Pipeline – United Utilities, Bridekirk Development of a new water supply pipeline connection from Thirlmere to West Cumbria including (within 	

Allerdale) A water treatment works with associated vehicular access, landscaping and temporary working areas off A595 near Blindcrake. A service reservoir, valve house with vehicular access and landscaping at Moota Hill. A pumping station with vehicular access, fencing and landscaping at Harrot Hill, Cockermouth. Underground mains supply from the proposed WTW to Quarry Hill, Broughton Cross and into Copeland Borough's boundary. Slip-lining of existing pipelines from Broughton Cross to Stainburn SR and from Cockermouth to Southwaite Farm incorporating the development of valve chambers, excavation and landscaping, temporary access, compounds, hard standings and other associated works. **Concerns raised about the traffic disruption and the scale of the map is insufficiently detailed to identify exactly where the pipe is to be located. Insufficient time to absorb such a large document. Routing and traffic management are the primary worries. How is this going to be managed and how long is the road to be closed?**
