Police

Also it was mentioned that large vehicles, i.e. lorries etc are going the wrong way down the one way system in Tallantire as they are having difficulty in getting round the corner at Fernbank House. Concerned in case there is an accident.

Pavement in Tallantire and Speed Limits

The pavement in Tallantire - this is due to being again at the end of February. Awaiting info from United Utilities as to when they are able to bury the cables.

Tallantire Wind Farm Inquiry

Have received the Agenda and Unconfirmed Minutes for meeting on Thursday 16th February in Bridekirk Dovenby School at 7pm.

Mr Ian McCambridge (Chair of Tallantire Wind Farm) has been looking into the running of the Community Fund which is to be set up to control the funds to be received from RES for the Windfarm. He has discovered that it would be best if one of the Parish Councils concerned be the responsible body for looking after the funds but with a Sub Committee to have day to day control of the management funds. RES will only be happy with a statutory body to hold the funds. He has suggested that Bridekirk P C be the responsible body. All present at the meeting agreed. Ian is to ask Matthew Horn of RES to convene a meeting for a Community Funds Committee. This committee is to consist of a County Councillor, District Councillor and one member of each Parish Council, i.e. Bridekirk Gilcrux and Plumbland. Ian is to represent Bridekirk PC on this Committee.

Also in the Unconfirmed Minutes of 21st June 2011, Ian was concerned with the following - 'A member of the public outlined that the project crossed the road and asked if a wheel wash would be needed at the crossing point., CG stated that it might and that it would be investigated. A member of the public asked if there would only be one site entrance. CG stated that contractors may look to use a different route but the turbine loads would have a set route'.

Ian was concerned regarding this entry in the Minutes as it was understood that all traffic would

be using the roads that were being built specifically for the construction of the wind farm. Ian is to bring this point up at the meeting on 16th February.

Clerk to contact CALC to seek guidance with being a responsible body for the funds etc.
