- **2.5.21** The minutes of the meetings held on Thursday 13th May 2021 were signed as a true record.

5.5. 22 Accounts :

The clerk reported on the ongoing issues around HSBC who have now 'closed the account in error'. They have said they will look into reinstating it within 10 – 15 working days, but that it is our responsibility to keep checking. In the meantime there are outstanding accounts to be paid again as all last months cheques were returned to the recipients. It was resolved that the clerk would pay the grass cutter and that Mr Armstrong would pay the instalment for the wall builder in Dovenby and both would be repaid as soon as possible. 8.5.21 Clerks report -

- Complaints about the standard of grass cutting have been received, clerk to notify the contractor.
- Need to consider where we hold the meetings going forward as the WI is no longer meeting in the school, which means our rental would effectively double as the cost was always split between the PC and the WI. It was resolved to ask if we were able to book the Parish Rooms on a regular basis and pay the equivalent rent for this service.

9.5.21 Flooding updates

- **Tallentire** –No flooding issues
- **Dovenby**. No flooding issues, however we are coming to the time where the work to clear the beck should commence and it was resolved to support the cost of the equipment required as previously done.

10. 5.21 Parish Maintenance –

- website is now looking very good and being well populated.
- Wall in Dovenby, progress is being made and the first payment is due.

Following an update on meetings etc. It was resolved that Mr Hodgson should make applications for the funding for this project to go ahead, this will lead to a package of funding through Environmental Agency, Cumbria County Council and if successful the match funding from Cumbria Community Foundation it was noted that without the CCF element the whole project is likely to be unable to go ahead.

the additional noise generated when the track is in use against regular traffic on the nearby road, this is in spite of the noise being heard by residents way outside the Parish.
