Minutes of the meeting of Bridekirk Parish Council held on Thursday 9th September 2021

- 1.7.21** Apologies for absence received Cllr J Farebrother; Cllr N Cockburn; Mr S Dumbill; Mr R Stenson; Mr F Armstrong
- 2.7.21** The minutes of the meetings held on Thursday 8th July 2021 were signed as a true record.
- 3.7.21** No declarations of interest
- 4.7.21** There were no members of the public present at the meeting
- 5.7.21** Accounts:

The clerk reported that the bank account is now set up from today and that as soon as the cheque from HSBC has been presented and cleared that the outstanding payments will be made. This will be done as previously agreed in the minutes over previous months.

- 9.7.21** **Flooding updates**
- **Tallentire** – No flooding issues
 - **Dovenby** – Update from Mr Buckley to confirm that there is now a pond situated behind the Ship Inn, with a capacity for 3 cubic metres and there have been level gauges installed.
- 10.7.21** **Parish Maintenance –**
- Lots of positive comments about the wall that is now completed in Dovenby.
 - The seat that is owned by the Parish Council and sited in the grounds of Bridekirk Church is now in an unusable condition and it was resolved to replace this one and to

site one in the newly walled area in Dovenby. Mr Coy to take the lead on this and pass on the cost for replacements to the Clerk for action.

- Road up to Tallentire Hill has now been resurfaced.
- There has been further activity around the discharge into the Beck by staff at The Ship, Environment Agency have spoken to the landlord and he is taking action. Watching brief to confirm that no further deposits are made.
- A speed reduction through Dovenby has been agreed and this will occur once the protocols have been completed.
- Mr Buckley will get a price for a digger to be used to undertake the maintenance work in the Beck to prevent flooding of local homes.
